 - Need more alumni-student interaction in the beginning

- Mike Kuykendall wanting to make connection to discuss synergies between CAS and Alumni Advisory Board leadership
- New Dean has expressed commitment to hydrogeology, field camp and capital raising
- g. Top BPSoG investment / fundraising considerations for upcoming year (ie., Field Camp)
 - Field camp is #1 concern
 - Endowment fund has not hit for FY 2025- will be deployable August 1st
 - 4.25% available of \$3 million for department (\$128,000)
 - Dean's office has expressed support for field camp initiative
 - CAS has made the new Life Sciences building the priority, and Oklahoma Legislature has passed funding for the new building as well
 - Likely to our benefit that field camp capital needed is a fraction of the
 Life Sciences budget
 - Fund department FIRST with the \$3 million endowment, then deploy capital gaps towards field camp
 - Resolve smaller projects first (sewer, water well, kitchen) before an overall rebuild. Need a development plan that aligns with long term strategic plan from OSU Facilities and BPSoG
 - Mike Gaskins and Kristie Ferguson Lawerence Walker Bart Gaskill interested in being on Ad Hoc committee for field camp strategy
